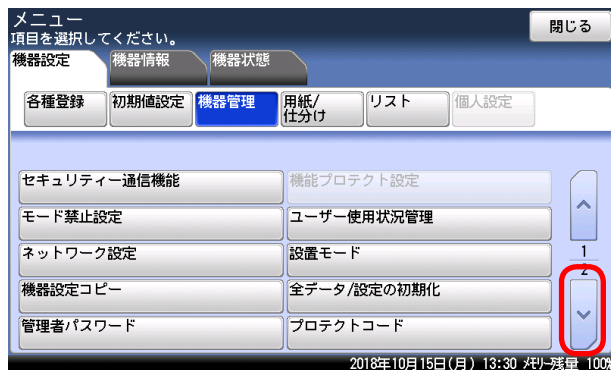
## 操作手順について

管理者パスワードを設定していない場合は、そのまま次の手順に進みます。
- 3 [自動ログアウト時間] を押します。

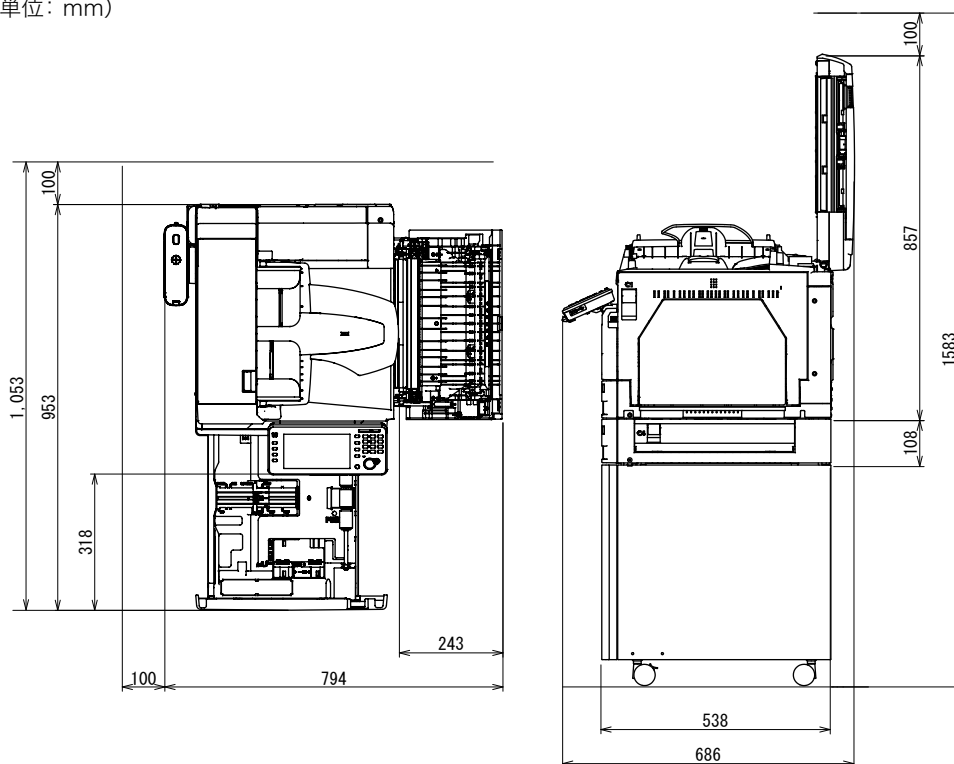

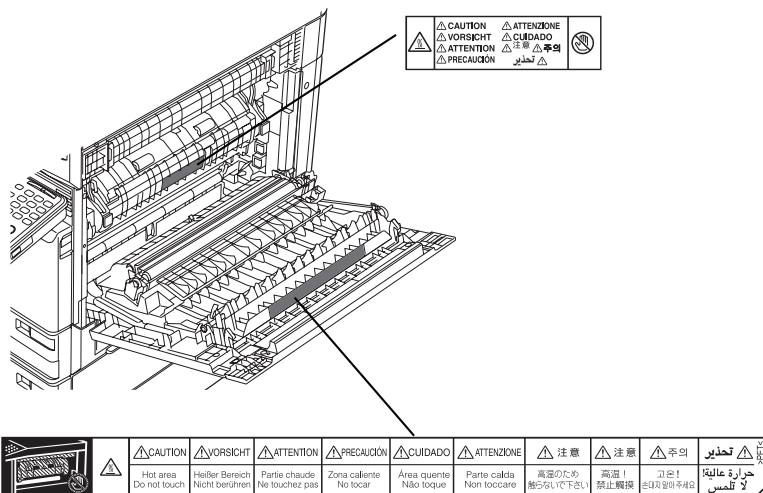


本体 + 増設給紙カセット + 専用台 + ハンドセット

## 日常のメンテナンスについて

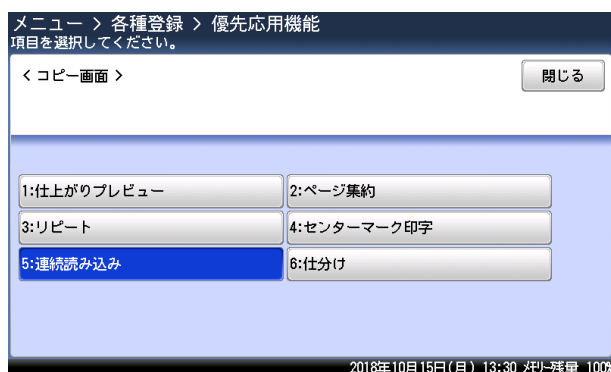

# ジョブメモリーを使用する

よく使う設定をジョブメモリーに登録しておけば、設定のための操作の手間を省けます。

## 補足

- ジョブメモリーは6個まで登録できます。
- プリンター機能は登録できません。
- ジョブメモリーの登録中は、登録中のモードに該当するモードキーが点滅して、ジョブメモリーの登録中であることを知らせます。

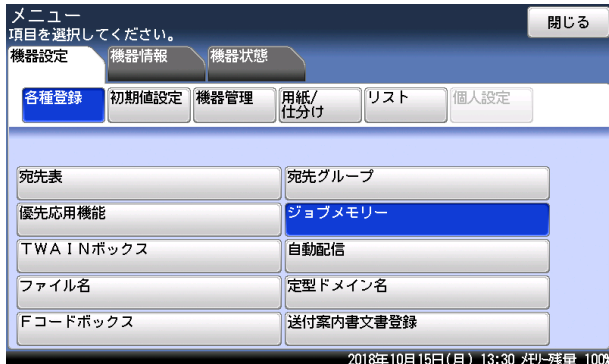

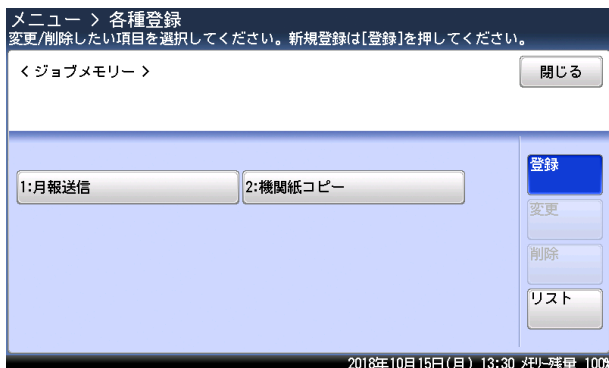

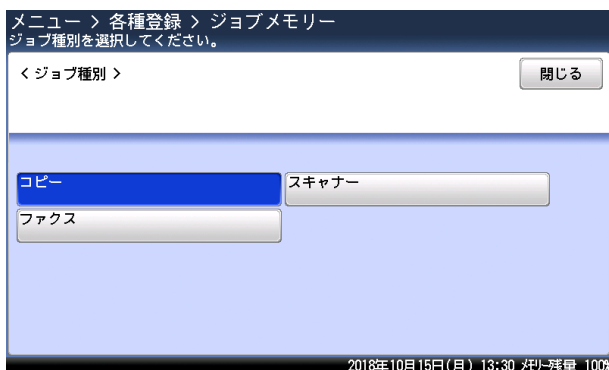

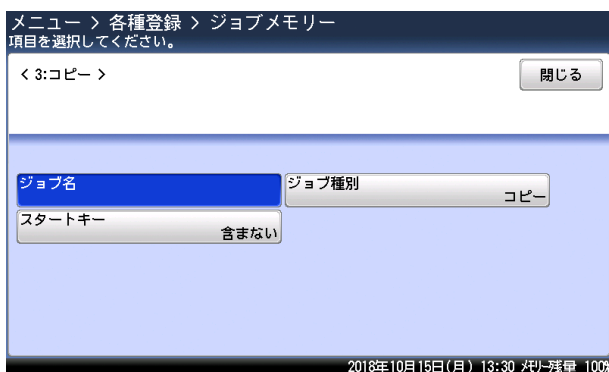

## 9 [スタートキー] を押します。

## 10 ジョブメモリーにスタートキーを含む場合は [含む]、含まない場合は [含まない] を選択し、[確定] を押します。

- ・含まない： ジョブメモリーを実行するときに、設定を確認して手動でスタートさせたい場合を選択します。
- ・含む： ジョブメモリーを実行するときに、自動でジョブをスタートさせたい場合を選択します。

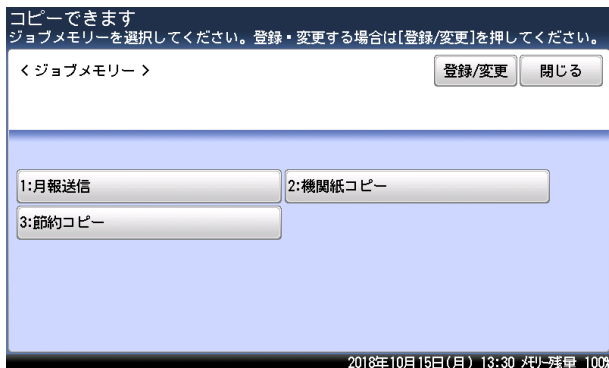

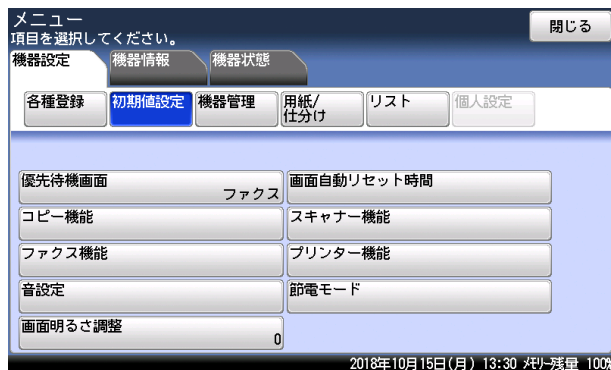

- ・[登録 / 変更] を押すと、ジョブメモリーの登録や変更 (→ 1-6 ページ)、削除 (→ 1-8 ページ)、リストのプリント (→ 1-8 ページ) ができます。

# 初期値を設定する

初期値とは、〈リセット〉を押したときに設定される値のことです。何も操作せずに一定時間放置したときも、初期値に戻ります。よく使う設定を初期値にしておくと、操作のたびに設定する手間が省けます。

- 1 〈メニュー〉を押します。
- 2 [機器設定] タブ、[初期値設定] の順に押します。



- 3 設定する項目を選択します。
- 4 初期値を選択し、[確定] を押します。

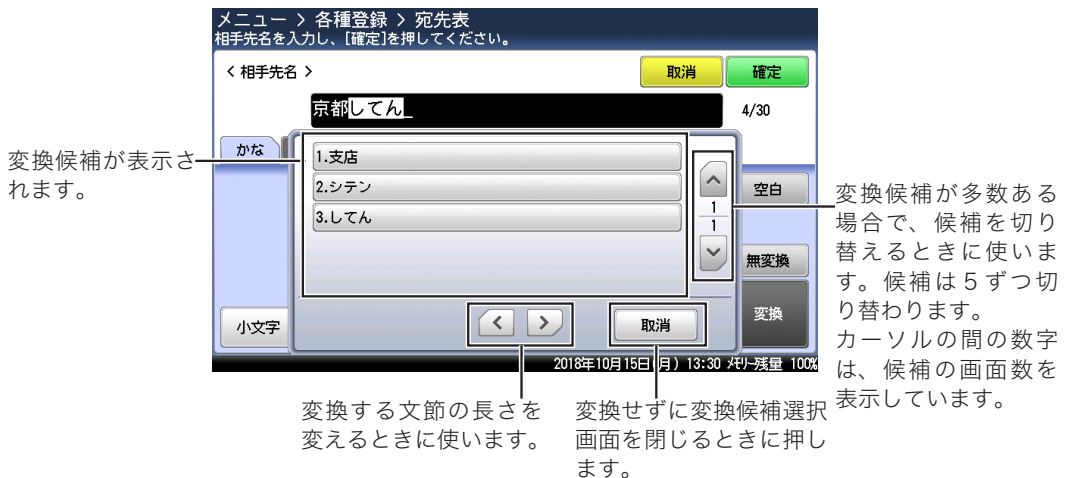

Preamble

The GNU General Public License is a free, copyleft license for software and other kinds of works.

The licenses for most software and other practical works are designed to take away your freedom to share and change the works. Preamble

The GNU General Public License is a free, copyleft license for software and other kinds of works.

The licenses for most software and other practical works are designed to take away your freedom to share and change the works.
